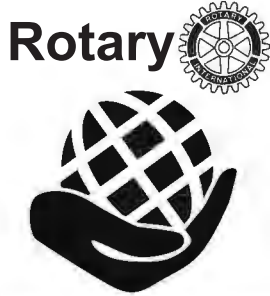


Rotary Club of Eagle River
